In Epistemology, Laurence Bonjour introduces the serious philosophy student to the history and concepts of epistemology, while simultaneously challenging them to take an active part in its ongoing debates. The text reflects Bonjour's conviction that the place to start any discussion of the theories of knowledge is with the classical problems, beginning with and centered around Descartes. Only after the groundwork for understanding epistemology is laid does Bonjour move on to the more contemporary revolutions against the classical approach. A versatile text that can be used in introductory-level epistemology courses, it can also be used by an upper-level epistemology class when supplemented by appropriate readings. This book is not, however, a simple reader of the different theories of knowledge. Epistemology prods students to think independently about the various epistemological approaches

presented in the text, and form their own conclusions, thus becoming active participants in the ongoing debate.

The understanding of the events taking place in a cell, a biological fluid or in any biological system is the main goal of biology research. Many fields of research use different technology to assess those events. Mass spectrometry is one of those techniques and this undergoes constant evolution and adaptation to always enhance the accuracy of the information provided. Proteomics provides a large panel of data on protein identity and protein expression that were made possible by mass spectrometry. For several years now mass spectrometry has become central to performing proteomic research, however this powerful tool is under constant evolution to be more sensitive and more resolute. More importantly mass spectrometry became a field of research focusing on new applications. Indeed, the complexity in biological systems relies on the changes of expression of transcription of proteins but also on the post-translational modification of proteins, the structure of proteins and the interaction between proteins, amongst others. As of now, several investigations tried to improve the quantification of proteins by mass spectrometry, the determination of post-translational modifications, the protein-protein and protein-nucleic acids interaction or the proteins structures. This book is structured as follows: after a brief introduction of the usual and most popular applications for mass spectrometry in proteomics, the most recent research and developments in mass spectrometry-based methodologies will be explored.

Following on from the success of the first edition, Short Answer Questions and MCQs in Anaesthesia and Intensive Care has been completely rewritten to reflect the changes to the final FRCA exam from a long essay based examination to compulsory short answer questions (SAQs). This guide aims to introduce methods and systems of answering questions succinctly and accurately. Almost all of the questions have been asked in the final FRCA since 1996 and most chapters carry more detail than required to reach a pass standard. The new edition takes a question-orientated approach and provides guidance for the final exam. Given the short time allowed for answering the SAQs, previous practice, prior to sitting the examination, is essential. Each of the twelve sections has a comprehensive set of multiple choice questions (MCQ) to the same standard as those set by the Royal College of Anaesthetists. It is vital that candidates practice MCQs as well as SAQs, and the ninety multiple choice questions that follow the SAQ paper carry just as much weight as the SAQ paper. The book has been structured as topic based sections and chapters, each of which can be followed and used to enable self-testing. This book is an invaluable revision aid during preparation for the final FRCA exam and, due to the breadth of content, also forms a useful ready reference throughout anaesthetic training.
